Vendor must provide own table/tent.

Vendor must set up prior to 3:00 pm on the day of the event or admittance may be denied. At the close of the event, entire space is to be cleaned and all trash removed by vendor. Vendor agrees to bring necessary power and light source-neither is provided by the Court Days Committee. **NO ELECTRICITY PROVIDED.**
